Rough-in work must be inspected before concealed. Final inspection required before occupancy permit will be issued. Work must conform to the **2018 International Mechanical Code** with local Amendments and City ordinances.

The fee for engaging in any activity that requires a permit from the Building Department or Public works Dept. Prior to the application and receipt of such permit shall be 1% of regular fee or \$100 which ever is greater.
